What is this product?

Type

"GMM Artificial Intelligence & Technology Equity Fund" is an Undertaking for Collective Investment in Transferable Securities (U.C.I.T.S.) of Law 78(I)/2012 as amended and as it is in force and of Directive 2009/65/EC. It is an Investment Department of UCITS "GMM FUNDS".

Duration

The Mutual Fund is of indefinite duration. Information on the mutual fund's dissolution can be found in the Rulebook and the Prospectus.

Objectives and Investment Policy

The investment objective of the Investment Compartment is to achieve high returns through a balanced investment of its assets in a diversified portfolio of stocks of companies listed on organized markets globally, and that operate in the field of Artificial Intelligence (AI) and new technologies such as digital transformation, big data analytics & storage, robotics, cybersecurity, semiconductor production, cloud & network providers, etc.

Additionally, the Investment Compartment may invest in ETFs across all the aforementioned sectors and may assume significant exposure to foreign currencies in order to enhance its expected return.

Secondarily, the Investment Compartment may invest in units of other UCITS (equity, balanced, money market), T-Bills, and bank deposits.

The percentage range for investments in equities, T-Bills, and deposits relative to the average valuation of its assets per calendar quarter is as follows:

Equities & ETFs: from 55% to 100%

UCITS, Deposits & T-Bills: from 0% to 45%

As part of its portfolio leveraging and investment risk hedging strategy, the Investment Compartment may take positions in derivative financial instruments, including both buying and selling. The Investment Compartment may engage in securities lending (Stock Lending) exclusively through organized markets in European Union member states.

As a result, the performance of the Investment Compartment is expected to be influenced by both microeconomic and macroeconomic factors.

The benchmark for the Investment Compartment is defined as a composite index consisting of: 70% Bloomberg Developed Markets Artificial Intelligence Price Return Index EUR & 30% 3-Month Euribor.

GMM Global Money Managers Ltd actively manages the Investment Compartment. Therefore, the portfolio composition may differ from the benchmark composition. The benchmark is used solely for comparison purposes and for calculating the performance fee. The manager from whom the benchmark is provided is registered under Article 36 of Regulation (EU) 2016/1011.

Investors can buy or redeem shares of the Investment Compartment on a daily basis during business days in Cyprus. Dividend income may either be reinvested or distributed to shareholders, as decided by the Management Company.

The impact of portfolio transaction costs on performance may be significant due to the strategy adopted by the Investment Compartment.

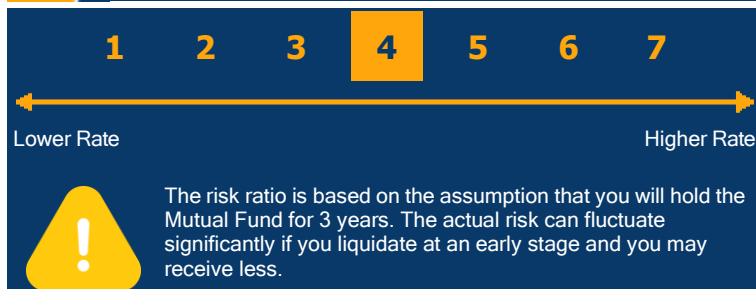
It is made clear that portfolio transaction costs are borne by the assets of the Investment Compartment.

Attention is drawn to the fact that the Investment Department is permitted to invest up to one hundred percent (100%) of its assets in the issuance of securities and money market instruments issued or guaranteed by a member state, by one or more local government organizations of a member state, by a third country, or by a public international organization in which one or more member states participate, provided that the cumulative conditions described in the Investment Department's Regulation are met. The member states, local government organizations, and public international organizations that may be included are as follows: IBRD, EBRD, ASIAN DEVELOPMENT BANK, INTERAMERICAN DEVELOPMENT BANK, KFW, NORDIC INVESTMENT BANK, KOMMUNALBANKEN NORWAY (KBN), EUROFIMA, COUNCIL OF EUROPE, EFSF, EIB, ESM, WORLD BANK, INTERNATIONAL FINANCE CORPORATION, US GOVERNMENT, GERMAN GOVERNMENT, NORWAY GOVERNMENT, SWISS GOVERNMENT, CANADIAN GOVERNMENT, AUSTRALIAN GOVERNMENT.

Investor profile

The Investment Compartment aims at medium- to long-term investors with an investment horizon over 3 years, wishing to enjoy capital gains by investing in a diversified portfolio of equities. Investors in this Investment Compartment must be willing to assume a medium level of investment risk.

What are the risks and what can I gain?



The product does not include any capital protection in relation to reported risks, which means that a part or the total amount invested may be lost.

The summary risk indicator is a guide to the level of risk of this Mutual Fund compared to other products. It shows how much possible it is, that the Mutual Fund will lose money due to movements in the markets or due to credit risk. On a risk return scale from 1 to 7, we have ranked the Mutual Fund at 4, which is a 'medium' risk category.

This means that the value of the assets of the M/F and consequently the price of the share have medium risk for intense positive or negative fluctuations, reflecting changes in the prices mainly of the equities in which it invests. Other risks that are materially related to the Mutual Fund and are not adequately reflected by the Risk Indicator are:

Liquidity Risk: This derives from the difficulty in selling assets at a fair price, at the preferred time, due to the potential lack of buyers. This event may put at risk the ability of the mutual fund to liquidate its units after its investors' redemption requests.

Counterparty Risk: The risk associated with a counterparty's ability in a financial transaction to discharge its obligations such as payment, delivery and settlement.

Operational risk: Some markets are less organized compared to most international markets, and consequently liquidating assets and settling transactions on those markets could entail greater risks for the Investment Compartment.

Risk of Inflation: This has to do with a reduction in the Investment Compartment's performance at fixed prices because of a rise in the general consumer price index.

Interest rate risk: Changes in interest rates could impact on the price at which certain financial instruments are traded, such as bonds or derivatives.

Derivatives risk: Using derivatives, either to hedge risk or to effectively manage it, could substantially affect how the portfolio performs.

The table describes how your investment can perform over the next 3 years if you invest 10,000 euros, assuming the maximum possible total cost of the product. The scenarios presented show how your investment may perform on a case-by-case basis, are an estimate of future performance based on past evidence and are not an exact indication. The actual return you will receive varies depending on market performance and the time you hold the product. The stress scenario shows the consequences to your investment under extreme market conditions and does not take into account the situation where we are unable to pay you or the case of early liquidation. The unfavourable scenario occurred for an investment between December 2021 - December 2022 (if you exit after 1 year) and between December 2019 - December 2022 (if you exit after 3 years).

The moderate scenario occurred for an investment between September 2016 - September 2017 (if you exit after 1 year) and between January 2016 - January 2019 (if you exit after 3 years).

The favourable scenario occurred for an investment between March 2023 - March 2024 (if you exit after 1 year) and between December 2018 - December 2021 (if you exit after 3 years).

What will happen if GMM GLOBAL MONEY MANAGERS LTD is unable to pay?

According to the law, the assets of the Mutual Fund cannot be held by the Management Company. To the contrary, the safekeeping of assets of the Mutual Fund is assigned by the Management Company, following permission of the Cyprus Securities and Exchange Commission, to a Depositary, that is responsible for the cash monitoring and management of the transactions of the mutual fund's assets in accordance with the instructions of the Management Company. There is no compensation or guarantee scheme for the investors of the Mutual Fund.

What is the cost?

The person who advises or sells you this product may charge you with additional costs. If so, this person will provide you with information about these costs and how they affect your investment.

Diminishing of the return (RIY) shows what impact the total cost you incur has on the return on investment you may have. The total cost takes into account both direct and indirect costs regarding one-off, ongoing and additional costs and possible early redemption penalties. The amounts shown here are the cumulative cost of the product itself, over three different holding periods. It is assumed that you invest €10,000 per year. Figures are estimates and may change in the future.

This shows how costs reduce your performance each year during the holding period. For example, it shows that if you liquidate during the recommended holding period, your average return per year is projected to be 18.3% before cost deduction and 15.4% after deduction of costs.

How long do I need to hold this product and can I withdraw money before it expires?

Recommended holding period: 3 years

The Mutual Fund does not have a minimum required holding period. You have the option to redeem part or all of your investment in any working day. The redemption of the units of UCITS is compulsory at the request of the unit-holder. In exceptional cases, where the circumstances require it and when it is considered necessary for the interest of unit-holders, it is permitted, at the request of the Management Company and following permission of the Cyprus Securities and Exchange Commission to suspend the redemption of units of the UCITS for a period up to three (3) months. The above suspension may be extended for a maximum of another three (3) months. The suspension of the redemption and its ceasing or revocation are published on the Company's website on the internet.

The announcement of the suspension of the redemptions specifies also when it is ended. During the suspension of the redemptions of units of the UCITS, applications for redemption by unit-holders may not be submitted.

How can I submit a complaint?
